

The Centers for Medicare & Medicaid Services Announces Approval for One-Year Extension

The Centers for Medicare & Medicaid Services recently received approval for a one-year extension of the Qualified Independent Contractor (QIC) Telephone Discussion and Reopening Process Demonstration activities in the Part A East (PAE) QIC jurisdiction. Appointment of Representative

An Appointment of Representative (AOR) form is required in order to appoint a person to request an appeal on behalf of a beneficiary or organization. Unless revoked, an appointment is considered valid for one year from the date the form is signed. Once the form is filed, it is valid for the duration of the appeal. Therefore, a signed form can be used for more than one appeal as long as the appeal is filed within one year of the date on the form.

If the person participating in the Telephone Discussion is the only one who is representing the provider and that person is not listed on the contact form or appeal request, an AOR must be on file with C2C.

The AOR must include the following required elements:

- Name of Party seeking representation (e.g., beneficiary, organization, etc.)
- Signature of Party seeking representation
- Date of signature of Party seeking representation
- Street address of Party seeking representation, including the city, state and zip code
- Name of appointed representative
- Signature of appointed representative
- Date of signature of appointed representative
- Street address of appointed representative, including the city, state, and zip code
- Appointed representative's profession status or relationship to party (e.g., attorney, guardian, conservator, power of attorney, etc.)
- Beneficiary Medicare Number (e.g., Medicare Beneficiary Identifier or Health Insurance Claim Number)
- Statement appointing the representative to act on behalf of represented
- Written explanation of the purpose or scope of the representation
